### **Commissioner's Report**

- Bylaws
  - 45+ hours of work into Bylaws changes
  - Coach's Meeting will be held in Feb to dig into depth of the changes; today's focus is initial presentation of Bylaws changes
  - Identified Board positions and responsibilities could streamline and consolidate, so the Board's focus was simply that - consolidate responsibilities, create an odd number on the Board, and reduce the number of required roles. We also aligned this with iPride positions.
- Miken/Worth is now doing all bats and balls; bats are already available for preorder
  - Can order 10 to get a discount off bats; could consider purchasing bats for league and teams purchase from league
  - Balls for league play, we still have balls used last year. Will use these balls for LEAGUE play until we run out and then will purchase new balls
  - Shootout will use the new Worth balls
- League is close to hitting next tier of league association; today we are considered a medium-sized league, but once we hit 20 teams, we are considered Large-sized league
  - With changes to ratings, we could see a reduction in E-division teams
  - If we have a need for additional E teams, and you're ready to coach or want to support coaching, please step up
- Executive Board purchasing iPad for league for ratings day, grievances, protests, etc. so all is electronic directly to Google drive
  - For ratings, will continue to do paper, and then a link in the coach's corner to input the ratings
  - Protests easier to have what we need to make the immediate changes after a protest
- Income and Expenses
  - No more Venmo or Cash App payments, so will only accept payments via Square
- Communication
  - GroupMe for all Players; strictly for information to all league members
  - Only admins of the group will be able to post. This will be for league information only and will not allow others to post or comment.
